### **Purpose and basis of processing:**

- Your personal data will be processed for the following purposes:
- reviewing application documents (Article 6, paragraph 1, letter a)
- fulfilling the Controller's obligations or rights under the contract (Article 6, paragraph 1, letter b) of the GDPR - performance of the contract
- fulfilling the Controller's legal obligations related to the contract, e.g., maintaining accounting records (Article 6, paragraph 1, letter c) of the GDPR - legal obligation),
- pursuing or defending against potential claims related to the cooperation or in connection with the need to prove certain facts that are of significant importance to the Controller in this respect (Article 6, paragraph 1, letter f) of the GDPR - legitimate interest); the deadlines for pursuing claims arising from the contract are specified in detail in the Civil Code,
- contacting representatives of contractors or contact persons regarding the cooperation (Article 6, paragraph 1, letter f) of the GDPR - legitimate interest).

### **Data Processing Period:**

Your Personal Data will be processed for the period necessary to achieve the above-mentioned purposes, taking into account the retention periods

a) Personal data processed for the purpose of identifying persons authorized to represent, conclude, and perform the Agreement will be processed for the duration of the Agreement, and after its termination, for the limitation period for any claims arising from legal provisions;

b) for the purpose of pursuing a legitimate interest in establishing, pursuing, and defending claims, and handling complaints.

### **Data Subject Rights**

You have the right to:

a) access and rectify your data (Articles 15 and 16 of the GDPR). You can exercise the right to rectification whenever your data is inaccurate or incomplete

b) erase and restrict data processing (Articles 17 and 18 of the GDPR). You can exercise these rights when the data is no longer necessary to achieve the purposes for which it was collected;

c) object (Article 21 of the GDPR). You can exercise this right due to your specific situation;

d) lodge a complaint with the President of the Personal Data Protection Office if you believe that the processing of your personal data violates the provisions of the GDPR.
